Building approvals

January 2022 | Economic brief

Residential building approvals

In January 2022, the number of residential building approvals in the Territory decreased by 17.9% to 23, the equal highest result with Queensland of the jurisdictions, which otherwise ranged from a 91.9% decrease in the Australian Capital Territory to a decrease of 27.9% in Tasmania. The decrease solely reflects house approvals, down from 28 to 23. Nationally residential building approvals decreased by 38.6% in the month.

Through the year, the number of residential building approvals in the Territory decreased by 25.8%, reflecting lower house approvals, down from 25 to 23, and unit and townhouse approvals, down from 6 to 0. Nationally, residential building approvals decreased by 24.7%.

In year-on-year terms, residential building approvals in the Territory decreased by 11.5% to 630, compared with an increase of 19.8% nationally (Chart 1). The Territory reported the only decrease of the jurisdictions, which otherwise ranged from an increase of 8.3% in Tasmania to an increase of 30.9% in Queensland (Chart 2). House approvals increased by 10.9%, unit and townhouse approvals decreased by 71.5%, and alterations, additions and conversions approvals decreased by 62.5%.


In year-on-year terms, the value of residential building approvals in the Territory increased by 5.2% to \$369 million, compared with an increase of 27.7% to \$91.1 billion nationally.

Non-residential approvals

In January 2022, the value of non-residential building approvals in the Territory decreased by 95.1% to \$15 million, reflecting a 99.2% decrease in public non-residential building approvals, due to significant defence related approvals in the previous month. Private non-residential building approvals decreased by 12.6%. Nationally, the value of non-residential building approvals decreased by 47.3% to \$2.3 billion.
