Residential building approvals

In August 2022, the number of residential building approvals in the Territory increased by 7.1% to 75, the strongest result of the jurisdictions, which otherwise ranged from a decrease of 18.9% in the Australian Capital Territory to an increase of 3.7% in New South Wales. Nationally, residential building approvals decreased by 0.2%.

In annual terms to August 2022, the number of residential building approvals in the Territory increased by 120.6%. This was the strongest result of the jurisdictions, which otherwise ranged from a decrease of 26.2% in Victoria to an increase of 8.3% in Tasmania. Nationally, residential building approvals decreased by 13.7%.

In the year to August 2022, residential building approvals in the Territory decreased by 21.5% to 623, compared with a decrease of 15.3% to 194,904 nationally (Chart 1). The Territory reported the third weakest result of the jurisdictions, which ranged from a decrease 36.8% in Western Australia to an increase of 30.5% in the Australian Capital Territory (Chart 2). House approvals decreased by 35.6%, unit and townhouse approvals increased by 33.3%, and alterations, additions and conversions approvals increased by 317.6%, from 17 to 71.


In the year to August 2022, the value of residential building approvals in the Territory decreased by 13.5% to \$357.9 million, compared with a decrease of 1.5% to \$88.1 billion nationally.


In August 2022, the value of non-residential building approvals in the Territory increased by 22.5% to \$56.8 million, reflecting an increase of 32.4% in private non-residential building approvals, and an increase of 13.1% in public non-residential building approvals. Nationally, the value of non-residential building approvals increased by 39.4% to \$5.2 billion.

Chart 1: Number of residential building approvals (moving annual total, original)




