# **Building approvals**

### Residential building approvals

In October 2022, the number of residential building approvals in the Territory increased by 3.0% to 69, the strongest result of the jurisdictions, which otherwise ranged from a decrease of 4.0% in Tasmania to an increase of 2.2% in Victoria. Nationally, residential building approvals remained flat.

In annual terms, the number of residential building approvals in the Territory increased by 115.6%. This was the strongest result of the jurisdictions, which otherwise ranged from a decrease of 45.0% in the Australian Capital Territory to an increase of 0.1% in South Australia. Nationally, residential building approvals decreased by 6.9%.

In the year to October 2022, residential building approvals in the Territory decreased by 9.5% to 649, compared with a decrease of 16.7% to 192,646 nationally (Chart 1). The Territory reported the second strongest result of the jurisdictions, which ranged from a decrease of 37.3% in Western Australia to an increase of 8.4% in the Australian Capital Territory (Chart 2). House approvals decreased by 25.0%, unit and townhouse approvals increased by 54.1%, and alterations, additions and conversions approvals increased by 500.0% from 12 to 72.

In the year to October 2022, the value of residential building approvals in the Territory decreased by 4.4% to \$372.2 million, compared with a decrease of 2.2% to \$89.2 billion nationally.

## Non-residential approvals

In October 2022, the value of non-residential building approvals in the Territory increased by 159.8% to \$117.9 million, reflecting an increase of 237.0% in public non-residential building approvals, partly offset by a decrease of 2.1% in private non-residential building approvals. Nationally, the value of non-residential building approvals increased by 0.3% to \$4.9 billion.

Chart 1: Number of residential building approvals (moving annual total, original)






Chart 2: Number of residential building approvals (year-on-year percentage change)
