The Australian Bureau of Statistics has reintroduced reporting trend estimates after they were suspended during COVID-19. Because of the limited number of trend data points, this brief will continue to use seasonally adjusted data until more trend data becomes available.

Monthly results (seasonally adjusted data)

In September 2023, retail trade in the Territory increased by 0.5% to \$325 million compared with the previous month (Chart 1). The increase was driven by the categories of 'food retailing' (contributing 0.9 percentage points (ppt)), and 'other retailing' (0.4 ppt).

The Territory, alongside Queensland and Australian Capital Territory, reported the second weakest result of the jurisdictions, which ranged from an increase of 0.1% in Western Australia to an increase of 1.8% in Tasmania. Nationally, retail trade turnover increased by 0.9% to \$35.9 billion.

Annual results (seasonally adjusted data)

Retail trade in the Territory increased by 2.6% in annual terms, the fourth weakest result of the jurisdictions (Chart 2). The increase was driven by the categories of 'food retailing' (contributing 2.8 ppt), and 'cafes, restaurants and takeaway food' (1.3 ppt).

Year-on-year results (original data)

In the year to September 2023, retail spending in the Territory increased by 3.7% to \$3.8 billion, the weakest result of the jurisdictions. In other jurisdictions, the change otherwise ranged from an increase of 3.8% in Tasmania and Queensland to an increase of 8.3% in the Australian Capital Territory (Chart 3). Nationally, retail spending increased by 5.3% to \$423.7 billion over the same period.

The Territory's year-on-year result was largely influenced by increased spending on 'cafes, restaurants and takeaway food' (contributing 2.0 ppt) and 'food retailing' (contributing 1.5 ppt).





Chart 2: Retail turnover (annual percentage change, current prices, seasonally adjusted)

The following analysis uses chain volume data, which has been adjusted to account for inflation. The ABS does not publish inflation adjusted data for the components of Territory retail trade.

Quarterly and annual results (seasonally adjusted)

In inflation adjusted terms, the Territory's seasonally adjusted retail turnover decreased by 0.3% to \$888 million in September quarter 2023 (Chart 4). This was the fourth weakest result of the jurisdictions. In other jurisdictions, results ranged from a decrease of 0.8% in South Australia to an increase of 0.7% in the Australian Capital Territory.

Territory retail turnover decreased by 1.1% in annual terms, which was the fourth weakest result of the jurisdictions. In other jurisdictions, the annual change ranged from a decrease of 3.1% in Queensland to an increase of 1.7% in Victoria and the Australian Capital Territory.

Nationally, retail turnover increased by 0.2% to \$98.3 billion in the quarter and decreased by 1.7% compared with the September quarter 2022 (Chart 5).

Year-on-year results (original)

In the year to September 2023, retail turnover in the Territory decreased by 2.0% to \$3.6 billion.

The Territory recorded the weakest year-on-year change of the jurisdictions. In other jurisdictions, the change ranged from a decrease of 1.7% in Tasmania and Queensland to an increase of 2.7% in the Australian Capital Territory. Nationally, retail trade decreased by 0.3% to \$395 billion over the same period.

Chart 4: Retail turnover (quarterly, inflation adjusted, seasonally adjusted)




Chart 5: Change in retail turnover (annual percentage change, inflation adjusted, seasonally adjusted)


