# **Building activity**

#### March quarter 2024 | Economic brief

The Australia Bureau of Statistics (ABS) building activity statistics includes residential and non-residential building work done and commenced, which is more updated information to that reported in the construction work done economic brief.

### **Quarterly results**

In the March quarter 2024, the trend value of total building work done in the Territory decreased by 0.5% to \$296 million. Nationally, the trend value of total building work done decreased by 1.3% to \$33.8 billion in the quarter.

#### Year on year results

In the year to the March quarter 2024, the total value of building work done in the Territory increased by 21.2% to \$1.2 billion (Chart 1).

The Territory recorded the largest increase in the value of building work done of all the jurisdictions, which otherwise ranged from a decrease of 0.7% in Tasmania to an increase of 7.3% in Western Australia. Nationally, the value of building work done increased by 3.0% to \$137 billion over the same period.

Non-residential building work done in the Territory increased by 37.0% to \$834 million, reflecting an increase of 43.4% in public sector work done and an increase of 22.9% in private sector work done (Chart 2). Residential building work done decreased by 5.2% to \$344 million, reflecting a decrease of 6.9% in private sector activity, partially offset by an increase of 0.9% in public sector activity (Chart 3).

Residential building work done comprised an increase of 3.5% in new houses to \$216 million, a decrease of 15% in alterations and additions to \$107 million and a decrease of 26.2% in new units to \$21 million.

## Building work yet to be done

In the March quarter 2024, the value of building work yet to be done in the Territory decreased by 9.4% to \$1.1 billion. This reflects a decrease of 12.2% in non-residential work yet to be done to \$929 million, which is partly offset by an increase of 10.2% in residential work yet to be done to \$169 million. Nationally, the value of building work yet to be done increased by 0.8% to \$106.3 billion over the same period.


Chart 2: Territory non-residential work done (moving annual total, inflation adjusted)
