## **Employment**

In August 2022, seasonally adjusted resident employment in the Territory increased by 1.0% to 135,334 persons. Part-time employment increased by 1.7% and full-time employment increased by 0.7%. Nationally, employment increased by 0.2%, with full-time employment increasing by 0.6%, partly offset by part-time employment decreasing by 0.6%.

Annually, seasonally adjusted resident employment increased by 4.2% in the Territory. Nationally, employment increased by 4.4% over the same period (Chart 1). In the year to August 2022, Territory employment increased by 2.3%, reflecting an increase in full-time employment of 3.8%, partly offset by a decrease in part-time employment of 2.7%. Nationally, year-on-year employment increased by 3.1%.


Despite increased employment, the Territory's seasonally adjusted unemployment rate increased from 3.5% in July 2022 to 4.5% in August 2022 (Chart 2). This change is largely due to increased participation in the month. Nationally, the monthly unemployment rate increased from 3.4% to 3.5%.


The seasonally adjusted participation rate in the Territory increased by 1.0 percentage points to 73.6% in August 2022. The Territory's participation rate is the highest of the jurisdictions, and well above the national rate of 66.6% (Chart 3).
