Residential building approvals

In July 2023, the trend number of residential building approvals in the Territory decreased by 5.3% to 36, the weakest result of the jurisdictions, which otherwise ranged from a decrease of 1.5% in Queensland to an increase of 8.4% in the Australian Capital Territory. Nationally, residential building approvals increased by 1.6%.

In annual terms, the trend number of residential building approvals in the Territory decreased by 44.6%. This was the second weakest result of the jurisdictions, which ranged from a decrease of 46.2% in the Australian Capital Territory to a decrease of 3.6% in South Australia. Nationally, residential building approvals decreased by 15.1%.

In the year to July 2023, residential building approvals in the Territory decreased by 4.6% to 542, compared with a decrease of 11.0% to 174,663 nationally (Chart 1). The Territory reported the third strongest result of the jurisdictions, which ranged from a decrease of 37.5% in the Australian Capital Territory to a decrease of 3.3% in New South Wales (Chart 2). Alterations, additions and conversions approvals decreased by 90.1% from 71 to 7, unit and townhouse approvals decreased by 26.2%, and house approvals increased by 14.5%.


In the year to July 2023, the value of residential building approvals in the Territory increased by 5.9% to \$350.5 million, compared with an increase of 3.2% to \$89.9 billion nationally.


In July 2023, the value of non-residential building approvals in the Territory increased by 147.6% to \$47.5 million, reflecting an increase of 252.2% in private non-residential building approvals, partly offset by a decrease of 52.7% in public non-residential building approvals. Nationally, the value of non-residential building approvals decreased by 29.4% to \$5.7 billion.

Chart 3: Territory residential building approvals (moving annual total)


