The Territory's estimated resident population increased by 0.4% (1,114 persons) to 251,654 in the March quarter 2023.

Net overseas migration (+1,463 persons) and natural increase (+582 persons) contributed to population growth while net interstate migration (-931 persons) detracted from population growth. Nationally, population increased by 0.7%.

In annual terms, the Territory's population increased by 0.9%, while nationally, population increased by 2.2% (Chart 1). Annual population change in other jurisdictions ranged from an increase of 0.4% in Tasmania to an increase of 2.8% in Western Australia (Chart 2).

Natural increase

In the March quarter 2023, the Territory recorded a natural increase of 582 persons, comprising 849 births and 267 deaths. In the year to March 2023, natural increase contributed 2,125 persons to the Territory's population, a decrease of 14.0% compared to the previous year.

Net interstate migration

Net interstate migration for the September and December 2021 quarters are impacted by the ABS making COVID-19 related methodological adjustments to its treatment of Medicare source data.


In the March quarter 2023, net interstate migration detracted 931 persons from the population, a worsening on the net loss of 310 persons in the March quarter 2022. There were 4,578 departures from, and 3,647 arrivals to, the Territory in the quarter.


In the year to March 2023, net interstate migration detracted 2,745 persons from the population, a worsening of 6.5% on the net loss of 2,578 persons in the previous year.

Net overseas migration

In the March quarter 2023, net overseas migration contributed 1,463 persons to the population. Nationally, net overseas migration contributed 152,192 persons.


In the year to March 2023, net overseas migration in the Territory contributed 2,749 persons to the population, an improvement compared to the net gain of 1,744 persons in the previous year (Chart 3). Nationally, net overseas migration contributed 454,361 persons.
