# Retail trade turnover (current prices)

The Australian Bureau of Statistics reintroduced reporting of trend estimates after they were suspended during the COVID-19 pandemic. However, due to irregular spending patterns over this period, trend estimates are not available from March 2020 to June 2022.

# Monthly results (trend)

In December 2023, retail trade in the Territory was flat at \$325 million compared with the previous month (Chart 1). The result was driven by 'cafes, restaurants and takeaway food' reducing by 0.2 percentage points (ppt).

The Territory reported the equal third weakest result of the jurisdictions, alongside New South Wales and Western Australia. Nationally, retail trade turnover increased by 0.1% to \$35.7 billion.

#### Annual results (trend)

Retail trade in the Territory increased by 2.9% in annual terms, the fourth strongest result of the jurisdictions (Chart 2). The increase was driven by the categories of 'food retailing' (contributing 2.0 ppt), and 'other retailing' (1.2 ppt).

# Year-on-year results (original data)

In December 2023, retail spending in the Territory increased by 3.4% to \$3.9 billion, the equal fourth weakest result of the jurisdictions alongside Victoria. In other jurisdictions, the change ranged from an increase of 1.7% in Queensland to an increase of 6.0% in the Australian Capital Territory (Chart 3). Nationally, retail spending increased by 3.1% to \$425.0 billion over the same period.


The Territory's year-on-year result was largely influenced by increased spending on 'food retailing' (contributing 1.8 ppt) and 'cafes, restaurants and takeaway food' (contributing 1.5 ppt).



The following analysis uses chain volume data, which has been adjusted to account for inflation. The ABS does not publish inflation adjusted data for the components of Territory retail trade.

# Quarterly and annual results (trend)

In inflation adjusted terms, the Territory's trend retail turnover was flat at \$889 million in December quarter 2023 (Chart 4). In other jurisdictions, results ranged from a decrease of 0.4% in New South Wales to an increase of 0.4% in Queensland.

Territory retail turnover decreased by 0.2% in annual terms, which was the sixth weakest result of the jurisdictions. In other jurisdictions, the annual change ranged from a decrease of 2.3% in New South Wales to an increase of 0.7% in the Australian Capital Territory.


Nationally, retail turnover decreased by 0.1% to \$98.0 billion, and by 1.4% compared with the December guarter 2022.

# Year-on-year results (original)

In 2023, retail turnover in the Territory decreased by 1.2% to \$3.6 billion (Chart 5).

The Territory recorded the fourth weakest year-on-year change of the jurisdictions. In other jurisdictions, the change ranged from a decrease of 2.4% in Queensland to an increase of 1.8% in the Australian Capital Territory. Nationally, retail trade decreased by 1.0% to \$393 billion over the same period.

Chart 5: Change in retail turnover (year-on-year percentage change, inflation adjusted, original)


