Quarterly result

The Darwin CPI increased by 2.1% in the March quarter 2022. Darwin recorded the fourth lowest quarterly increase of the capital cities. The other capital cities ranged from a 1.7% increase in Sydney to a 3.3% increase in Perth. The eight capital cities' average CPI increased by 2.1%.

The greatest contributors to the quarterly increase in the Darwin CPI were transportation (up by 5.0% contributing 0.53 ppt), and food and non-alcoholic beverages (up by 2.7% contributing 0.5 ppt) (Chart 1).

The increase in transportation was driven by automotive fuel (up by 12.0% contributing 0.46 ppt) due to an oil price shock caused by the Russia-Ukraine conflict. Nationally, automotive fuel increased by 11%.

The increase in food and non-alcoholic beverages was driven by meats and seafoods, and fruits and vegetables, each contributing 0.13 ppt.

Housing increased by 2.0% (contributing 0.42 ppt), driven by increases in rents (up 3.1% contributing 0.19 ppt) and new dwelling purchases (up 2.5% contributing 0.17 ppt).

Annual result

Darwin CPI increased by 5.5% (Chart 2). This was the fourth strongest increase of the capital cities. The categories with the largest annual change were transportation (up by 17.6%) and insurance and financial services (up by 9.4%).

In other capital cities, the CPI ranged from an increase of 4.4% in Sydney to an increase of 7.6% in Perth. The eight capital cities' average CPI increased by 5.1%.

Year-on-year Result

Darwin CPI increased by 5.9% in the year to March 2022, the highest of the capital cities (Chart 3). The eight capital cities' average CPI increased by 3.9%.

The largest price increases were in transportation (up by 13.0%), housing (up by 11.6%) and furnishing, household equipment and services (up by 6.9%). Clothing and footwear (down by 3.4%) and communication (down by 0.8%) reported the only decreases.

In other capital cities, CPI growth ranged from an increase of 3.2% in Melbourne to an increase of 5.2% in Perth.

Chart 1: Consumer price index percentage point contribution (quarterly change)




Chart 2: Consumer price index (annual percentage change)




Chart 3: Capital cities consumer price index (year-on-year percentage change)


