Residential building approvals

In February 2022, the number of residential building approvals in the Territory increased by 230.4% to 76. The Territory reported the second highest result of the jurisdictions, behind the Australian Capital Territory (536.0%). The Territory's increase reflects an increase in both house and unit approvals (up from 23 to 35, and from 0 to 38, respectively). Nationally residential building approvals increased by 81.2%.

Through the year, the number of residential building approvals in the Territory increased by 24.6%, reflecting the higher number of unit and townhouse approvals and partially offset by lower house approvals. Nationally, residential building approvals decreased by 8.0%.

In year-on-year terms, residential building approvals in the Territory decreased by 12.7% to 645, compared with an increase of 16.8% nationally (Chart 1). The Territory reported the only decrease of the jurisdictions, which otherwise ranged from an increase of 0.2% in Tasmania to an increase of 20.8% in New South Wales (Chart 2). House approvals increased by 0.2%, unit and townhouse approvals decreased by 48.2%, and alterations, additions and conversions approvals decreased by 58.3%.

In year-on-year terms, the value of residential building approvals in the Territory increased by 6.2% to \$376 million, compared with an increase of 26.0% to \$91.7 billion nationally.

Non-residential approvals

In February 2022, the value of non-residential building approvals in the Territory increased by 33.2% to \$21 million, reflecting a 366.5% increase in public non-residential building approvals. Private non-residential building approvals decreased by 31.6%. Nationally, the value of non-residential building approvals increased by 177.6% to \$6.3 billion.

Chart 1: Number of residential building approvals (moving annual total, original)






Chart 2: Number of residential building approvals (year-on-year percentage change)
