Building approvals

Residential building approvals

In March 2022, the number of residential building approvals in the Territory increased by 35.5% to 103, the second highest result of the jurisdictions, which otherwise ranged from a decrease of 28.3% in Victoria to an increase of 55.3% in the Australian Capital Territory. The increase reflects an increase in house approvals, up from 35 to 42, and alterations, additions, and conversions approvals, up from 3 to 61. Nationally residential building approvals decreased by 9.8%.

Through the year, the number of residential building approvals in the Territory decreased by 37.6%, reflecting lower house approvals, down from 164 to 42, partially offset by higher alterations, additions and conversions approvals, up from 1 to 61. Nationally, residential building approvals decreased by 34.5%.

In year-on-year terms, residential building approvals in the Territory decreased by 32.4% to 583, compared with an increase of 6.9% nationally to 215, 467 (Chart 1). The Territory reported the weakest result of the jurisdictions, which otherwise ranged from a decrease of 9.8% in Tasmania to an increase of 15.3% in New South Wales (Chart 2). House approvals decreased by 36.9%, unit and townhouse approvals decreased by 46.6%, and alterations, additions and conversions approvals increased by 191.7%.

In year-on-year terms, the value of residential building approvals in the Territory decreased by 24.4% to \$320.6 million, compared with an increase of 17.1% to \$89.8 billion nationally.


Non-residential approvals

In March 2022, the value of non-residential building approvals in the Territory decreased by 15.5% to \$17.7 million, reflecting a 30.7% decrease in public non-residential building approvals, partly offset by a 6.4% increase in private non-residential building approvals. Nationally, the value of non-residential building approvals decreased by 8.3% to \$5.8 billion.




Chart 2: Number of residential building approvals (year-on-year percentage change)

Chart 3: Territory Residential Building Approvals (moving annual total)




