The Territory's estimated population declined marginally (by 44 persons) in the September quarter 2021 to 245,865 persons. Natural increase (+643) contributed to growth while net interstate migration (-637) and net overseas migration (-50) detracted from growth. Nationally, population increased marginally (by 12,056 persons, or 0.05%).

In annual terms, the Territory population decreased by 0.2%, while nationally, population increased by 0.3% (Chart 1). Annual population growth in other jurisdictions ranged from a decrease of 0.5% in Victoria to an increase 1.1% in Queensland (Chart 2).

Natural increase

In the September quarter 2021, the Territory recorded growth from natural increase of 643, comprising 935 births and 292 deaths. In the year to September 2021, natural increase contributed 2,649 persons to population, an increase of 4.2% compared to the previous year.

Net interstate migration

The Territory's net interstate migration (NIM) is highly volatile, reflecting the relatively young and transient population. NIM is being impacted by the ABS recently making COVID-19-related methodological adjustments to its treatment of Medicare source data used to estimate interstate migration flows.


In the September quarter 2021, net interstate migration detracted 637 from the population, a worsening on the net loss of 211 persons in the September quarter 2020. There were 5,866 arrivals to, and 6,503 departures from, the Territory in the quarter.

In the year to September 2021, the Territory recorded a net loss of 2,930 persons to other jurisdictions, a 30.9% increase on the net loss of 2,239 persons in the previous year.


Net overseas migration

The impact of COVID-19 border restrictions has caused significant disruption to usual migration flows. In the September quarter 2021, net overseas migration detracted 50 persons from the population. Nationally, net overseas migration detracted 19,942 persons over the same period.

In the year to September 2021, net overseas migration in the Territory detracted 304 persons, a worsening compared to the positive contribution of 72 persons in the previous year (Chart 3). Nationally, net overseas migration detracted 67,268 persons, a worsening compared to the positive contribution of 75,627 persons in the previous year.


