## Residential building approvals

In May 2024, the number of residential building approvals in the Territory was unchanged at 25, the third weakest result of the jurisdictions, which ranged from a decrease of 3.8% in the Australian Capital Territory to an increase of 9.9% in Western Australia. Nationally, residential building approvals increased by 7.0%.

In annual terms, the number of residential building approvals in the Territory decreased by 35.9%. This was the weakest result of the jurisdictions, which otherwise ranged from a decrease of 14.7% in Tasmania to an increase of 55.6% in Western Australia. Nationally, residential building approvals decreased by 1.2%.

In the year to May 2024, residential building approvals in the Territory decreased by 39.4% to 368, compared with a decrease of 10.0% to 162,543 nationally (Chart 1). The Territory reported the weakest result of the jurisdictions, which otherwise ranged from a decrease of 20.1% in New South Wales to an increase of 14.0% in Western Australia (Chart 2). Alterations, additions and conversions approvals decreased by 62.5% from 8 to 3, house approvals decreased by 39.4%, and unit and townhouse approvals decreased by 34.1%.


In the year to May 2024, the value of residential building approvals in the Territory decreased by 17.0% to \$322.2 million, compared with a decrease of 2.5% to \$88.6 billion nationally.


In May 2024, the value of non-residential building approvals in the Territory increased by 156.5% to \$106.9 million, reflecting an increase of 301.9% in public non-residential building approvals, and an increase of 12.2% in private non-residential building approvals. Nationally, the value of non-residential building approvals increased by 36.4% to \$6.4 billion.
