Residential building approvals

In June 2024, the number of residential building approvals in the Territory increased by 7.4% to 29, the strongest result of the jurisdictions, which otherwise ranged from a decrease of 5.5% in the Australian Capital Territory to an increase of 3.5% in South Australia. Nationally, residential building approvals increased by 1.1%.

In annual terms, the number of residential building approvals in the Territory decreased by 21.6%. This was the weakest result of the jurisdictions, which otherwise ranged from a decrease of 19.6% in New South Wales to an increase of 58.8% in Western Australia. Nationally, residential building approvals decreased by 1.8%.

In 2023-24, residential building approvals in the Territory decreased by 38.5% to 362, compared with a decrease of 8.5% to 162,892 nationally (Chart 1). The Territory reported the weakest result of the jurisdictions, which otherwise ranged from a decrease of 19.1% in New South Wales to an increase of 22.7% in Western Australia (Chart 2). Alterations, additions and conversions approvals decreased by 62.5% from 8 to 3, house approvals decreased by 38.2%, and unit and townhouse approvals decreased by 38.1%.


In 2023-24, the value of residential building approvals in the Territory decreased by 15.5% to \$315.6 million, compared with a decrease of 1.7% to \$89.0 billion nationally.


In June 2024, the value of non-residential building approvals in the Territory increased by 119.6% to \$234.7 million, reflecting an increase of 259.3% in private non-residential building approvals, and an increase of 80.3% in public non-residential building approvals. Nationally, the value of non-residential building approvals decreased by 37.2% to \$4.0 billion.


