In the September quarter 2022, the trend value of engineering construction work done in the Territory decreased by 4.5% to \$457 million.

In year-on-year terms, the Territory's engineering construction work done increased by 23.8% to \$2.0 billion (Chart 1). This reflects public sector activity increasing by 37.9% mainly due to work for roads, highways and subdivisions (contributing 28.4 percentage points) and private sector activity increasing by 30.2% mainly due to work for heavy industry (contributing 33.1 percentage points).

The Territory recorded the largest year-on-year increase of the jurisdictions, which otherwise ranged from a 6.6% decrease in Western Australia to a 12.2% increase in South Australia (Chart 2).


Engineering work commenced

In the September quarter 2022, the value of Territory engineering construction work commenced was \$485 million. Private sector activity comprised 51.7% of the work commenced and was largely related to works for heavy industry.

In year-on-year terms, public sector work commenced decreased by 63.7% to \$472 million, mainly reflecting decreases in work for roads, highways and subdivisions (detracting 60.7 percentage points) (Chart 3). Private sector work commenced increased by 629.8% to \$5.6 billion, mainly reflecting significant increases in work for heavy industry in the March quarter.

Nationally, the value of engineering work commenced increased by 38.2% to \$114.7 billion over the same period.


Chart 1: Engineering work done (moving annual total, inflation adjusted)


Chart 2: Engineering work done
